## A WEST COAST DOUBLE-HEADER!

### BOOTH AND V.I.P. INFORMATION, RULES FOR PARTICIPATION

1. Booth registrations are confirmed by receipt of the signed application/contract accompanied by check, money order, credit card or cash. (First come, first served).
2. Small booths are 10' x 10', and come with 1 table, chairs, sign, two badges and electricity. 10' x 20' booths come with 2 tables, chairs, sign, 3 badges and electricity.
3. Extra tables may be ordered and paid with this form at \$25.00 each. Tables are 8 feet x 30 inches.
4. Names of booth workers must be submitted with application, and **each person** must produce identification at check-in to obtain a badge. Badges must be worn at all times. Additional certified employees must pay \$15.00 per day. Helpers must be valid employees of the exhibitor or have no instrument trading history.
5. Only one firm or entity may occupy each booth. This includes casual instrument traders.
6. No instrument sales or purchases will be allowed outside the venue, in the lobby, or in the loading or parking areas from Friday through Sunday.
7. **Ten minute ban on electrical instrument tryouts every hour on the hour, to allow acoustic demonstrations. Noise levels will be monitored and controlled throughout the show.**
8. All exhibits must be left in place through 4 p.m. on Sunday except by management approval.
9. Neither Tex★US Guitar Shows, Inc. nor the promoters, will assume responsibility for any theft, damage, accidents or deals that might occur during the course of the show.
10. Any non-exhibitor who distributes literature of any kind will be charged a 10' x 10' booth fee.
11. Vendors **must furnish receipts** with all sales and trades, without regard to size or value of items. Customers are required to present these receipts to remove items from the hall.
12. Management may refuse a booth application for any reason.
13. Sales or display of illegal, unlicensed or "bootlegged" goods is expressly prohibited. This includes but is not limited to audio, video, printed and/or manufactured items.
14. Every exhibitor is advised to acquire a California resale permit. To apply call 800-400-7115 then touch 10.
15. V.I.P. Buyer fee is \$200.00 for entire three day weekend.
